MINUTES OF MEETING OF ADVISORY NEIGHBORHOOD COMMISSION 1C  
October 4, 2000

A meeting of the Commissioners of Advisory Neighborhood Commission 1C (the "ANC") convened at Marie Reed School on October 4, 2000.

### 1. ATTENDANCE

Commissioners present: Faith, Johnson, Llorente, Miscuk, Schott  
Commissioners absent: Letsinger, Softli, Wright  
Persons from the community were present in addition to commissioners.

### 2. NOTICE OF MEETING

Each Commissioner and the community received notice of the meeting.

### 3. PRESIDING OFFICER AND SECRETARY

Commissioner Schott presided, and Commissioner Llorente kept Minutes of the meeting.

### 4. CALL TO ORDER AND INTRODUCTION OF COMMISSIONERS

The meeting was called to order at 7:10pm by Commissioner Schott. There was not a quorum at that time. Commissioner Johnson joined the meeting at 7:40pm, creating a quorum.

### 5. ANNOUNCEMENTS & REPORTS

- o Public Safety: Lt. O'Connor gave the police report: crime was down 8% from last year, 40% down from last month. Later Sgt. Eyester was introduced.
- o Both voter registration and the school board forum scheduled for 10/21 were mentioned.
- o Cmmr. Miscuk presented the Treasurer's report. Cmmr. Schott asked for reimbursement for copying expenses. The request was approved with 4 ayes, 1 opposed.
- o Cmmr. Johnson announced a meeting on the Digital Divide to be held 10/5/00.

### 6. NEW BUSINESS

- o Cmmr. Johnson presented a resolution of support for Tom Oliver's organization for Adams Morgan Festival 2001. A discussion followed. The motion was moved and seconded. A motion to table the motion was defeated 3 to 2. The motion was approved 3 to 2.
- o Sterling Patrick was asked for a report on the 1620 T St. group house, but

did not preset one.

- Cmmr. Miscuk presented a resolution to endorse the PTA resolution supporting the Chime program, run by Dorothy Marchak (sp.?). The motion was moved and seconded. The discussion continued until Cmmr. Llorente left the meeting.

#### 7. **ADJOURNMENT**

The meeting ended when a quorum was lost.
