Dear Chairperson Silverman:

At a duly-noticed public meeting held on 4/6/2022, with a quorum present, Advisory Neighborhood Commission 1C voted (6-0-0) to support the attached letter of Dissent Regarding Redistricting Strivers' Section from ANC 1C to ANC 1B. This letter was submitted in the final Ward 1 Task Force Redistricting Report on April 3, 2022, by Task Force Committee member and 1C01 resident and former ANC 1C Chair Amir Irani. This letter was a collaboration by Adams Morgan residents and ANC 1C members.

The residents of the Strivers' Section are better served by ANC 1C representation, given their interests in the nearby shopping, parks, restaurants, community centers and schools that are in 1C. The move of 894 residents of the Strivers' Section from ANC 1C to 1B does not further the goals of respecting communities of interest, favoring continuity and stability, or advancing equity in representation.

We ask that you keep Strivers' Section in ANC 1C, as those residents have been for the last 32 years.
